# **CONSULTANT AGREEMENT**

THIS CONSULTANT AGREEMENT (hereinafter "Agreement") is made and entered into this \_\_\_\_\_ day of May, 2013 by and between the

FORT LEE BOARD OF EDUCATION with offices located at 2175 Lemoine Avenue, Fort Lee, New Jersey 07024 (hereinafter the "Board")

#### AND

ANGEL CONSULTING, LLC, having a tax payer identification number of 274331987/000 (hereinafter the "Consultant")

**NOW THEREFORE** the Board and the Consultant, for the consideration herein specified, agree as follows:

In consideration of mutual promises contained within this Agreement, the Consultant agrees to perform services set forth in paragraph 2. In return, the Board agrees to pay the Consultant such amounts as are specified upon the conditions set forth herein.

#### 1. TERM:

The Consultant accepts employment effective May 7, 2013 through December 31, 2013 on a per diem basis, as set forth at sub-section A of Article 3 of this Agreement, and such additional time as deemed necessary in consultation with the Board President.

#### 2. **RESPONSIBILITIES:**

- A. The Consultant shall provide services to the District at the discretion of the Board President. It is acknowledged that the Consultant's experience in the field of education makes him uniquely qualified to provide this service. The Board may deploy the consultant to the following areas that include, but are not limited to: (1) improving student achievement, (2) organizational efficiency; (3) teacher quality, (4) administrative oversight, (5) special education, and (6) curriculum. The Consultant shall also serve as a resource and advisor to the Chief School Administrator and perform any other duties as requested by the Board.
- B. The parties acknowledge that Dr. John Richardson will attend Board of Education meetings at the request of the Board. Dr. Richardson's attendance at such meetings will be billed at his hourly rate.

- C. The Consultant shall report directly to the Board of Education. It is expressly understood between the parties that the Consultant is not serving as the Chief School Administrator's mentor for purposes of certification requirements of the State of New Jersey
- D. <u>Outside Activities</u>: The Consultant agrees that Dr. John Richardson shall exclusively devote his time, attention, and energy to the business of the Board. Dr. Richardson may engage in writing activities and speaking engagements at his discretion. For any other business activities, Consultant must receive the Board's written consent.

#### 3. **COMPENSATION:**

A. <u>Salary</u>: The Board shall pay the Consultant on a per diem basis at a rate of six hundred, forty-five (\$645.00) dollars per day for the term of this Agreement. The Consultant shall work a part-time schedule not to exceed three (3) days per week. The Consultant may be required to attend regular Board meetings at an hourly rate of eighty (\$80.00) dollars per hour.

Any adjustment in salary made during the life of this Agreement shall be in the form of an Amendment and shall become part of this Agreement, but it shall not be deemed that the Board and the Consultant have entered into a new Agreement.

- B. The Consultant shall not be entitled to any benefits or payments therefore, including but not limited to, paid leaves of absence, paid holidays, paid vacations unless agreed to by the Board, medical insurance, pension, or other benefits other than hourly payment noted in sub-section A of Article 3 of this Agreement.
- C. The Consultant shall be responsible for all State and Federal taxes associated with this Agreement.

# 4. PROFESSIONAL LIABILITY:

A. The Board agrees that it shall defend, hold harmless and indemnify the Consultant from any and all demands, claims, suits, actions and legal proceedings brought against the Consultant in his official capacity as an agent of the Board, provided the incident arose while the Consultant was acting within the scope of this Agreement and, as such, liability coverage is within the authority of the Board to provide under State law. In the event the Consultant is subject to criminal proceedings brought against him in his official capacity as an agent of the Board, the Board shall not be responsible to defend him or hold him harmless for the costs and expense incurred in the defense of such criminal charges unless the final disposition of such charges are in favor of the Consultant.

B. Consultant agrees to maintain all levels of insurance as required by New Jersey law and the New Jersey Department of Education, including general liability, worker's compensation and professional liability insurance.

#### 5. **RENEWAL/EXTENSION:**

Any notice of renewal or extension of this Agreement shall be agreed by and between the Board and the Consultant on terms and conditions as agreed by the parties.

#### 6. **TERMINATION:**

This Agreement may be terminated by:

- A. Mutual agreement of the parties.
- B. Disability of the Consultant. If a question exists concerning the capacity of the Consultant to return to his duties, the Board may require the Consultant to submit to a medical examination, to be performed by a doctor licensed to practice medicine. This examination shall be done at the expense of the Board. The physician shall limit his report to those factors that prohibit the Consultant from performing his duties.
- C. Upon thirty (30) days written notice without cause by either party.

#### 7. COMPLETE AGREEMENT:

This Agreement embodies the entire agreement between the parties hereto and cannot be varied except by written agreement of the undersigned parties.

#### 8. **CONFLICTS**:

In the event of any conflict between the terms, conditions and provisions of this Agreement and the provisions of the Boards policies, or any permissive state or federal law, then, unless otherwise prohibited by law, the terms of this Agreement shall take precedence over the contrary provisions of the Boards policies or any such permissive law during the term of this Agreement.

#### 9. SAVINGS CLAUSE:

If, during the term of this Agreement, it is found that a specific clause of this Agreement is illegal in Federal or State law, the remainder of this Agreement not affected by such ruling shall remain in force.
