The meeting was called to order at 6:34 p.m. by Board President, Ms. Colbath.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

Mr. Kravitz shared that he is administratively pulling the 2022-2023 District Calendar from tonight's agenda. Mr. Kravitz further shared that Policy 2422 (Comprehensive Health & Physical

Education) is being reviewed and will appear on a future Board agenda.

Mr. Kravitz recognized the following student achievements:

- For the first time since Fort Lee has participated in Bergen County's Key Club, the newly elected Lieutenant Governor for the school year 2022-2023 is one of our own! Tessa Lee
- FLHS's Debate Team **placed 1st in the county and 2nd for overall teams.**
- FLHS Winter Guard won 1st place overall in their division in the Monroe Township Winter Guard Competition. They also received the highest score of all divisions.
- Steffi Yakoff made it to the 16 and under doubles semifinals of the USTA Easter Bowl in Indian Wells, CA
- Tyson Lowe and Alexandra Manatovic were both unanimously named 1st Team All-County for Winter Track.
- Today is the kick off for spring sports
- The Class of 2022 has college acceptance to several big name schools
