PURPOSE OF THE SPECIAL BUSINESS MEETING

The purpose of tonight's Special Public Budget Hearing Meeting was to convene in open session to present the 2022-2023 Final Budget for discussion and approval.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

Mr. Kravitz presented the 2022-2023 Final Budget. Board conversation ensued confirming the updated budgeted Capital Reserve Projects for the 2022-2023 Final Budget including the Fort Lee High School Retaining Wall Repair (\$330k), the Fort Lee High School HVAC Upgrade (1st Floor West Wing) (\$863k), the Fort Lee High School HVAC Upgrade (2nd Floor West Wing) (\$897k), the Fort Lee High School HVAC Upgrade (1st Floor East Wing) (\$402.8k), the Fort Lee High School HVAC Upgrade (West Gym) (\$746k), the Fort Lee High School HVAC Upgrade (East/Main Gym) (\$1.5MM), the Fort Lee High School HVAC Upgrade (Locker Rooms) (\$561.6k), the Fort Lee High School HVAC Upgrade (Team Room and Office) (\$298.4k), the Lewis F. Cole Middle School HVAC Upgrade (Gym) (\$661.5k) totaling (\$6.3MM). Ms. Stassou shared her dissatisfaction that all of the Middle School will not be included in the 2022-2023 budgeted capital projects.
