CALL TO ORDER BY THE PRESIDENT

The meeting was called to order at 6:36 p.m. by Board President, Ms. Colbath.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

Mr. Kravitz shared the Official Release of our District's School Self-Assessment for Determining Grades under the Anti-Bullying Bill of Rights Act for 2020-2021.

Mr. Kravitz introduced two Fort Lee High School student representatives, Kevin Sun and Min Young Sok and asked them to share any student concerns and/or questions.

Student Representatives Report: The student representatives shared that the student body is stressed about finals and hope modifying the final exams will appeal to students.

Ms. Taylor introduced Mark Vidovich, President and Erik Korman, Area Manager of Pomptonian. Mr. Vidovich shared a detailed Food Service Presentation.

Ms. Stassou expressed her discontent of the quality of the food based on student complaints. Mr. Vidovich addressed her concerns, and further shared that any parent, administrator, student or Board member should reach out to Mr. Korman or Mr. Vidovich via email and/or phone with any complaints or concerns so they can be adequately addressed.

Ms. Taylor thanked Mr. Korman for his relentless dedication distributing meals to families in need during the COVID-19 pandemic.

School Security Committee: Chairperson Mr. Rubino shared he was in communication with the Fort Lee Police regarding evaluating two additional Class III Officers, and is targeting securing a total of three Class III Officers by the beginning of the 2022-2023 school year.
